Minutes September 20, 2023

MEETING

A meeting of the Nederland Economic Development Corporation was called to order at 4:39 p.m. at the Nederland Economic Development Corporation, 1519 Boston Avenue, by President Bret Duplant.

QUORUM

Board members present: Bret Duplant, Don Albanese, Anthony Toups, Mitch Macon, Mike Roebuck. Others present Kay DeCuir Nederland EDC Executive Director and Jim Wimberley, NEDC Attorney Absent: Billy Wayne Doornbos and Kasey Taylor.

INVOCATION AND PLEDGE

Bret Duplant gave the Invocation and led the Pledge

HIGGINBOTHAM INSURANCE PRESENTATION

Over the past few months, the Director expressed concern regarding the rising costs of the NEDC Property Insurance. The Director discussed this topic informally with various board members at different dates and times. The Director asked Jimmy Harrison with Higginbotham Insurance to compare the current property policies and see if Higginbotham Insurance could provide a better rate. The policies in question related to four (4) separate properties owned by the NEDC, including (i) the NEDC Office, (ii) the Salon building on Twin City Hwy, (iii) the House/Restaurant on Twin City (with the preceding two tracts being a part of the "Off Boston Development" project) and (iv) the two adjacent refurbished Boston Avenue properties (recently vacated and awaiting new owners), with each of the four (4) properties quoted for coverage separately, each of which quotes were within the approval authority of the Director. The Director invited Harrison to attend the September 20, 2023 before she would bind the coverage with Higginbotham. Harrison provided, during open session, a quick overview of the NEDC properties and quotes for insuring any or all NEDC Properties (specifically excluding the old Bank of America building at 1308 Boston Avenue due to potential joint ownership with the City). This open session informational presentation was inadvertently not identified on the posted agenda. Mr. Harrison provided various quotes for each of the four (4) separate properties and confirmed to the Board that the proposed policies being offered by Higginbotham Insurance provided not less than identical coverage as the NEDC had with its current provider, but with lower deductibles and substantially lower premiums. The Board unanimously agreed that the Director should move forward to bind the coverage but requested that Higginbotham. before binding coverage, determine if the premium costs could be reduced materially if the deductibles were increased to not less than \$5,000.00. Upon receipt of this possible modification, the Board approved the Director's decision to transfer coverage to Higginbotham, without the necessity of delaying the final acquisition of such coverage, with time being of the essence due to the fact that the significantly more expensive existing coverage and related policies were to automatically renew on October 1, 2023. Once the premium reductions (due to increased deductibles) were determined by the Director, the Director would secure the new policies.
