- 1. January 11, 2024, The Regional Economic Forecast Luncheon, NEDC has a reserved table.
- 2. Asbestos Abatement is now complete for 1308 Boston Avenue.
- 3. 1308 Boston Avenue Contract with the City, NEDC and their attorneys are cleaning up the contract to move forward and close.
- 4. CBAs- Neighborhood Vet Hospital, RAD Graphics/Dancewear and Tees2urDoor have been monitored and officially closed.
- 5. The other CBAs awarded are under construction so they have no monitoring at this time.
- 6. The two CBAs under continued monitoring are Checkers and Juanita's. Both businesses are doing well.
- 7. There are no new PRIDE Applications at this time.
- 8. 1215 Boston Avenue has been surveyed and just waiting to close.

- 9. November 30, 2023 at 7:00 pm, Energy Transfer will make a community presentation on their major upcoming projects at the NISD PAC Center.
- 10. Concert Series are great for the community but we will need more sponsors next year. The Fall Market Day was very successful and will be held only once a year. The expenses to host the market are adding up so one time a year is affordable for NEDC. Many new businesses share that this event brings in revenue like a Black Friday or larger than Black Friday and Small Business Saturday. Both events hosted by NEDC are very beneficial for our community.
- 11. Atlanta Avenue "Off Boston" project has kicked off. We will meet the last Monday of each month for an update and debrief at the construction trailer. Project completion is scheduled for the end of May 2024. Four trees will have to be removed, mostly are small by the fence behind Checkers and one large tree that will be in the way of the retail cottage behind the hair salon.
- 12. NEDC is purchasing the alleyway from the City of Nederland.
- 13. NEDC Meetings will be moved to 5:00 pm starting in December 2023.
- 14. 1217 Boston Avenue and 1118 Atlanta Avenue are receiving prospect calls and tours.
- 15. December 13, 2023 will be the next NEDC Meeting.
