- -We made 7 trips to Troop Industrial over the last week to drop off donations that we had received for the hurricanes that have hit Florida and other states surrounding it.
- -Power is on at Off Boston Development. Once the project is complete, we will have an open house for realtors and the public to tour the units.
- -1132 Atlanta Avenue on Off Boston closes next week.
- -The fiberglass Dutch shoe we had made is now being painted by the art students at Nederland High School. We will be giving scholarships for their help. The one shoe we are having painted now will be at the Fall Market Day to show what we are selling. 14 more fiberglass Dutch shoes are in production now. The shoes are made gold with NEDERLAND molded into the top for \$420.00, unpainted.
- -The 3 picnic and 3 octagon tables for Off Boston have been assembled, except for one that was missing a few pieces. The name plates for the sponsors of the tables will be installed shortly.
- -We are still working on getting quotes for the tear-down of the bank drive-thru.
- -Next week, the Director will be at the TEDC conference.
- -The banners for our Off Boston Light poles came in this week. We have a Christmas banner and a banner for the remainder of the year.
- -October 22 and October 29 is our Celebration of Business Dinner.
- -QuickBooks Training will be November 14.
