Taxable sales to be brought to the city will be \$7,353,348.00 over the next 10 years and 16 permanent jobs. This project will be monitored by NEDC for 2.4 years.

# COMMUNICATION

Kay DeCuir shared the following with the Board;

- The final concert of the third annual Fall Concert Series will be this Thursday with Cajun Harmony and food truck vendor Taco Rey. At the November meeting she will present the costs incurred by NEDC to promote this quality-of-life event.
- September 21<sup>st</sup> will be the eighth year of the NEDC Fall Market Day. This will actually be the 11<sup>th</sup> market because several years there were two markets. This is a huge production so the focus moving forward will be one market the third Saturday in October each year. There will be 5 Nederland Police Officers assisting with the opening and closing of the event but due to the large number of vendors this year, over 130, there will be two designated gates for entry and exit.
- Letters notifying the closing of Boston Avenue and the 1311 Boston Avenue parking lot were delivered to the Nederland Post Master to inform the post office employees of the closed parking lot.
- 1217 Boston Avenue and 1118 Atlanta Avenue properties have been shown multiple times and may have potential buyers in the next month.
- Next week the NEDC Board will hold a formal groundbreaking on Tuesday or Wednesday, September 24 or 25 for the "Off Boston" Atlanta Avenue Expansion. Mrs. DeCuir will secure the media and contact board members to confirm the date of groundbreaking. Once the groundbreaking takes place, N&T Construction will move to the site to begin construction.
- \$5000.00 will be required as down payment by buyers to secure the property they choose for their new business. Most small businesses cannot afford to put a large sum of money on a down payment. The funds will be refunded once construction is finished and credited to the buyer at closing.
- Mrs. DeCuir will be on vacation November 7-10.
