The Director shared the following with the Board;

- The Nederland EDC 2025-2026 Budget Workshop will be held at the July Board meeting on July 16, 2025 at 4:30 P.M.
- The NEDC Director reached out to the franchise owner of Popeye's and found out they will be reopening the location at 2621 U.S. 69 Access Rd, Nederland, TX 77627, but not the location at 1804 FM 365, Nederland, TX 77627. The NEDC Director would like to attend the International Shopping Center in Las Vegas in 2026 to meet with additional franchise owners to bring more businesses to Nederland.
- The NEDC is renegotiating a new contract with the City of Nederland involving Cheryl Dowden and the Finance Department continuing to assist in the NEDC finances. We are wanting to amend the money we were paying to the City of Nederland to save \$4,000.00.
- The NEDC is working with Jerry Diaz for our concert series on October 2nd, 9th, 16th, and 23rd.
- The NEDC has been attending ribbon cuttings, Business of the Month, Coffees, and helping sell memberships for the Nederland Chamber of Commerce.
- The NEDC received a check for \$1,000.00 from the Southeast Texas Economic Development Foundation for working on the Cost of Living Index for the entire region every quarter.
- The NEDC is working with department leaders at the City of Nederland to confirm they will set up the barricades we rent out for the concerts and Fall Market Day. They have agreed.
- The NEDC will be closed on July the 4th in observance of the holiday.
- The NEDC Realtor helping with our Off Boston units, Heather Lange, has them all listed on Crexi, Southeast Texas MLS, and the properties are advertised daily on social media. She has had a few leads and is working with as many commercial agents as she can.
- June 24th, the NEDC will be performing a walk-thru at our Off Boston units to make sure everything is completed, so we can close out the project.
- The Director of the NEDC will be out of the office from July 1st-14th.
- We are waiting on a city ordinance for 1311 Boston Avenue to continue with the event center.
