Kay DeCuir presented an Executive Director's Overview to the Board giving an update of 2014 activities and projects such as the publishing of twelve Economic Upbeat Newsletters and the establishment of a new group of business women, which has created a great networking opportunity for local businesses. Kay informed the Board that in 2015, the Economic Upbeat will be published on a Quarterly basis instead of monthly and we will work with the City and Chamber to rollout a Strengths, Weaknesses, Opportunities and Threats (SWOT) Survey to local businesses to build on strengths and uncover unknown weaknesses, opportunities and threats within our business community such as, what suppliers do we need to bring in to the area.

Board Members stated they were pleased with the progress made during 2014 and emphasized the need for continued harmony with the NEDC and City to continue moving our community forward.

Don Albanese inquired about the Sterling Ridge construction status and Kay informed him that they had begun laying water lines and were stopped as they needed approval of final plat.


ADJOURN
