- Financials for December 2023
 - i. Financials are strong and we need to watch our reserve accounts for special projects in Downton Revitalization.
 - ii. We will need to have a discussion to bond the Atlanta Avenue Expansion which the architect is ready to submit for sealed bids and/or fund the project with our reserves which will be short.
 - iii. Mike Roebuck mentioned opening a new Money Market Account at Wells Fargo to possibly gain 3-4% interest.
- Kay discussed about the upcoming Workforce Development Conference to be held on March 30-31, 2023 which is part of the grant received from the City of Nederland. The 2-day conference will be held at First Baptist Church Nederland.
- Kay mentioned she will lead a June Market Day to be held on June 10, 2023 from 10-4pm as we usually do in October. The October Market tends to boost the economy in the city and she believes the June Market though it will be hot should help to increase the sales tax revenue. The Boston Avenue stores were requesting another market. Kay sent out emails to all former vendors and the reply was positive. Market booth space was increased by \$10.00 since the Market just completed 7 years with no price increase. Kay will hire NPD to help assist with the entrance and closing of the market. Kay mentioned leaving out the one block that was opposed to the October Market and complained about the market. No commercial will be run for this new event.

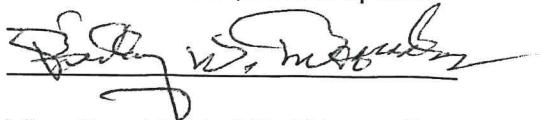
The NEDC Board reconvened into regular session at 5:33 pm. A motion was made as stated below:
