RESOLUTION NO. 2018-01

FINANCIALS

Kay DeCuir shared the December 2017 through April 2018 Financials with the Board of Directors. She pointed out

- the total Sales Tax Receivable from December 2017 through April 2018 was \$405,004.98
- the total Excess Revenue Over Expenses from December 2017 through April 2018 was \$1,519,896.11
- the Year-To-Date budget is \$757,762.00 and the total YTD Revenue Over Expenses through April 2018 was \$628,275.48
- the total Fund Balance as of April 2018 was \$2,785,315.20 after deduction for Reserve Fund and Pending CBA Awards.
- approximately \$200,000.00 will be moved from the Fund Balance to the Investment Account
- the total interest earned from December 2017 through April 2018 was \$38,728.50

- Hargrove Engineering will close Friday on the two buildings located on Highway 69


ADJOURN


There being no further business, a motion was made by Billy Neal and seconded by Bert Rogers to adjourned the meeting at 5:15 pm.
